

East Bridge Lofts LLC

#11 NATIONALLY **#1** IN SOUTH CAROLINA

On June 6, 2014, a Charleston, South Carolina jury awarded Fifty-Five Million Dollars (\$55.0m) to the East Bridge Lofts Property Owners Association and its homeowners in a defective condominium conversion case. Plaintiffs brought suit in late 2010, alleging that the conversion was defectively performed, and that the developers had covered up structural and other deficiencies. Plaintiffs sued the single purpose entity (SPE) builder, the SPE developer, the alleged de facto Texas parent/management company of the builder and developer, and a dozen subcontractors and suppliers.

Numerous subcontractors settled before trial for \$5.4m. Others settled during trial for \$0.85m. Various primary carriers for the SPEs tendered policy limits totaling \$6.0m during the trial, and one umbrella/excess carrier paid \$6.0m after Plaintiffs' closing argument for a total of \$18.25m collected before verdict.

Plaintiffs presented a \$23.0m repair estimate to the jury for the repair of the fourteen buildings containing two hundred condominiums, and argued for a punitive damage award of three times actual damages. The jury awarded \$22.0m in actual damages and \$33.0m in punitive damages, for a total verdict of \$55.0m. Post trial, the Court awarded \$3.36m in attorney fees on Plaintiffs' unfair trade practices cause of action, for a total award of \$58.36m. Plaintiffs are pursing collection efforts against remaining recalcitrant primary and excess insurance carriers.

This record-setting verdict follows behind a string of separate, prior successes for both firms, including their representation of state government in defective construction cases. Mr. Lucey represented the Medical University of South Carolina in a defective research center claim, recovering over one-third of the original cost. Mr. Buckley represented the State of South Carolina in connection with a mold contamination claim at the Governor's Mansion after an extensive renovation of that iconic structure. Both Mr. Lucey and Mr. Buckley have handled construction claims for local universities. Both firms seek to expand their practices further into public and commercial infrastructure. In

an era of tightening budgets, Mr. Lucey and Mr. Buckley encourage their public clients to hold their contractors accountable rather than condemn building/ infrastructure problems to the resolution of future budgeting requests.
